QE Duration Rotation Model FAQs

What time is the page updated?

Typically sometime between 10:30pm and midnight EST. And if you are a subscriber to the Quantifiable Edges subscriber letter, you can use that as a "deadline". The page should always be updated by whatever time the letter goes out. Since I manually check the automated signal files before publication, I cannot say exactly when it will be posted. But prior to sending out the subscriber letter it will be done.

Are you sure the Action Summary was updated tonight?

If you believe the page should have been updated by the time you are checking, but it still appears to be old, try and refresh your cache. Most browsers will save portions of webpages to cache. So when you visit the page, it may be showing you the images that are already stored on your computer from last night, rather than the current images that are posted to the web. In most browsers you can simply hit CTRL-F5 and it will refresh the entire page. At that point, you should be able to see the "current" Action Summary. If it still looks the same as the night before, then send an email to support@quantifiableedges.com or a Twitter message to @QuantEdges

Does the model use leverage?

No. It will always be 100% long, and the allocation will either be 100% one ETF, or 50% split between 2 of them. The ETFs traded are TLT, IEF, and SHV.
