

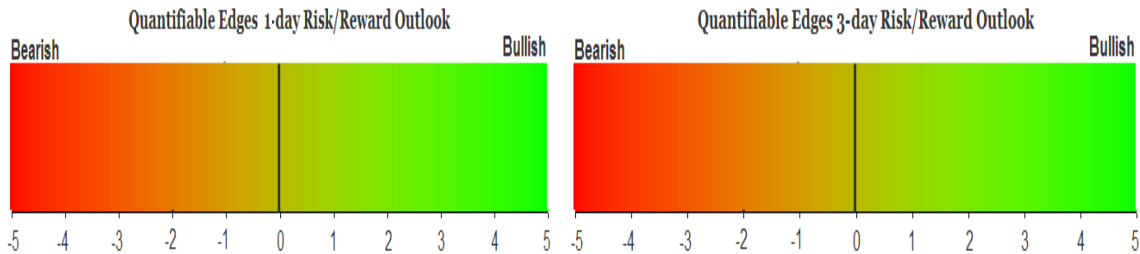

Market Overview



Tonight's Research Points

- An inside day after an unfilled gap up to a 50-day closing high has led to a short-term bullish tendency since 1998.
- The Aggregator System is flat.
- The NDX Aggressive Trend Timer is flat.

The Bottom Line

Still somewhat positive expectations, but an overbought market. The Aggregator System remains neutral, and I'm still flat and awaiting the next opportunity.

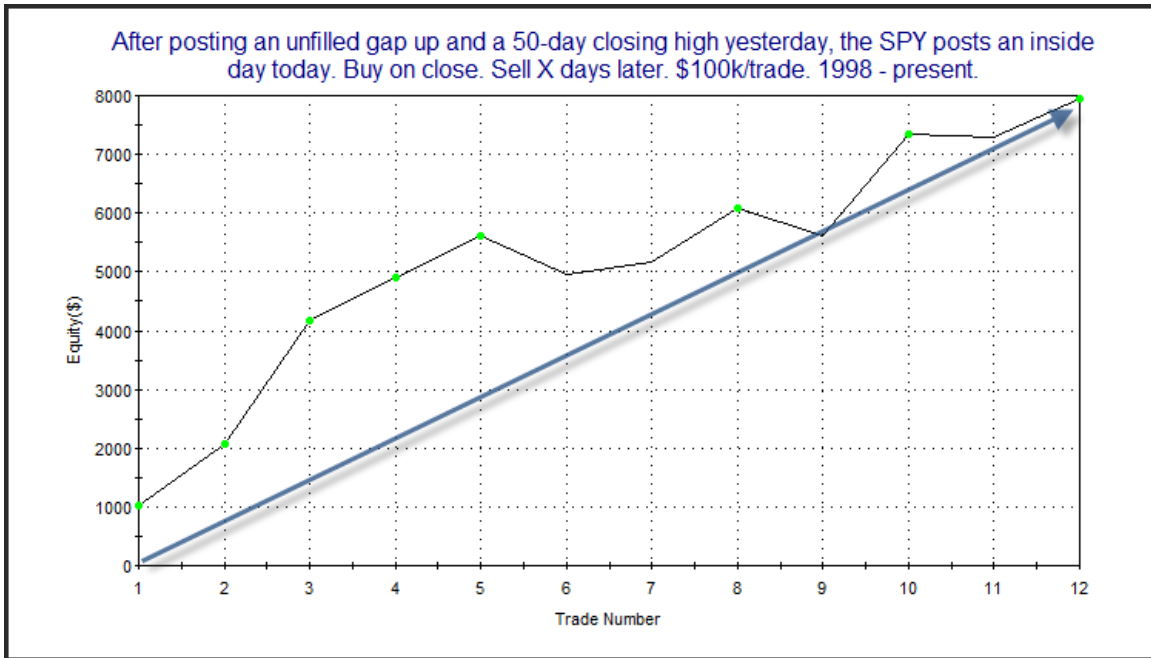
The Evidence

Thursday was a quiet day with mild pullbacks in most indices. The SPX fell 0.2% and the Nasdaq and Russell dropped 0.1%. Breadth was somewhat negative as the NYSE Up Issues % came in at 45% and the Up Volume % was 39%. Total NYSE volume rose just slightly from Wednesday's levels.

The Quantifinder showed a few studies tonight that looked at the narrow range or the fact that Thursday was an inside day. While some of those studies appeared bearish, the downside implications only held up when the market was in a long-term downtrend. We are nowhere near a downtrend as the market has been consistently hitting new highs for some time now. Tonight I took a look at a setup more specific to the current situation. I examined inside days following a 50-day closing high that occurred with an unfilled gap.

After posting an unfilled gap up and a 50-day closing high yesterday, the SPY posts an inside day today. Buy on close. Sell X days later. \$100k/trade. 1998 - present.

Since 1998 there has been an apparent tendency to finish up the next day. Below is the equity curve using a 1-day exit strategy.



Instances here are a bit low and the stats are borderline, but with a decent looking equity curve and little else to go on tonight I've decided to take these results under consideration.

I have updated the [Aggregator](#) chart below.



Once again tonight the green Aggregator line remains above 0. The positive value means the net expectation from the Active Studies List is for upside over the next few days. Meanwhile the black Differential line is again below 0. The negative value means the SPX has outperformed expectations over the last few days. So net expectations are for upside but the SPX has outperformed recent expectations. This is considered a neutral configuration. A neutral configuration can be seen on the chart whenever both lines are on opposite sides of zero. Due to this the Aggregator System stayed flat at the close.

The green Aggregator line is tentatively set up to remain above 0 on Friday. Of course this could change if bearish evidence emerges. Meanwhile the Differential Pivot will be 1,278.36. This is 0.4% below Thursday's close. This means it would take a drop of at least this much for the SPX to be considered "oversold", which would cause the black Differential line to move back above zero.

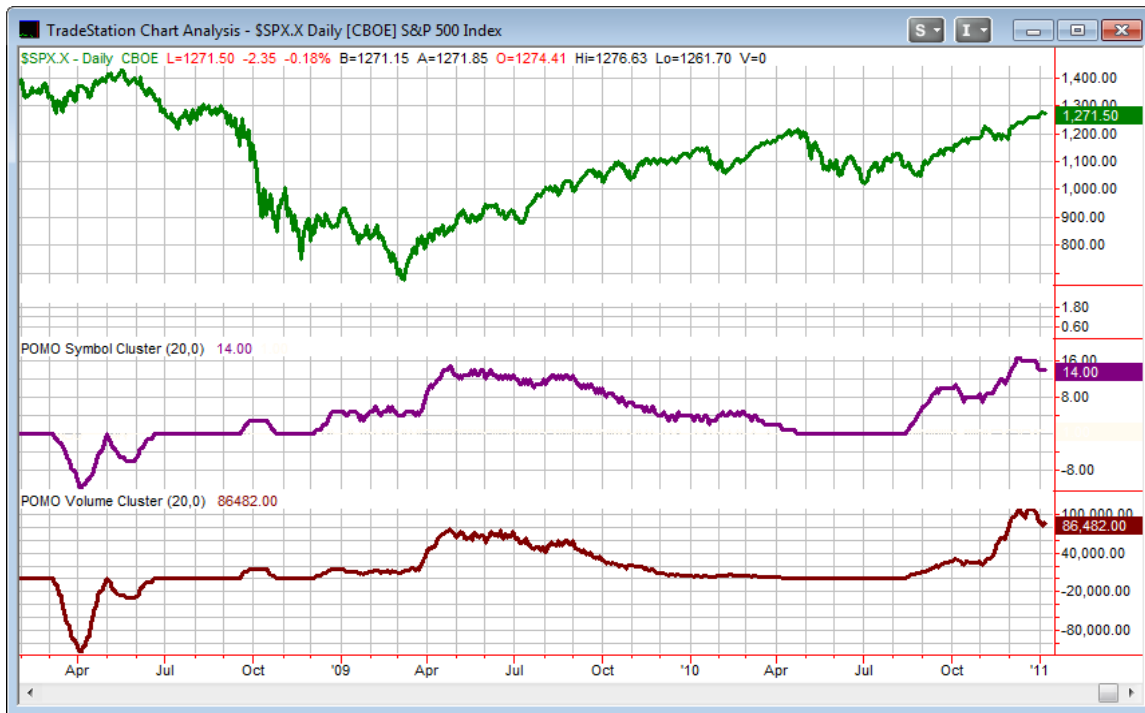
My market bias is still neutral. I am looking for a more pronounced edge along with solid risk/reward in order to establish the next position. I am approaching the market with an open mind and am willing to take a trade in either direction should I find compelling evidence.

Intermediate-term Outlook (2 weeks – 2 months)– updated 1/10 – neutral to slightly bullish

Intermediate-term indications remain mixed. New highs continue to be made each week, and until price weakness is evident I will likely continue to favor the bullish outlook.

I've been updating the POMO chart each week in the Letter. For those who may not recall below is a brief refresher on POMO. Beneath that I have updated our POMO indicator chart.

POMO stands for Permanent Open Market Operations and it is how the Fed goes into the open market to buy securities. The net effect of this buying is an influx of cash into the system. It appears a portion of that cash makes its way to the stock market and works as a bullish influence. A "POMO Day" is simply a day where these operations take place... The chart below (shows a couple of POMO indicators). The top pane is the S&P 500. The middle pane is the rolling number of days in the last 20 that have been POMO days. The bottom pane is the total amount of money infused into the system over the previous 20 days.



Fed POMO activity picked up again this past week. The 20-day totals are off their peak levels but still very high. Monday and Tuesday are both scheduled for additional Fed buying. Wednesday is not, but the Fed schedule for the next month will be released on Wednesday at 2pm EST. This should provide a nice clue as to the potential tailwind that the Fed might be providing to the markets in the coming weeks. Right now the recent POMO activity is high and that should still continue to act as a positive for a bit longer.

Subscribers should note that I gave a special presentation to gold subscribers this past week on the construction of the POMO indicators. I also answered questions on them, shared the Tradestation code, and provided links to the Fed website where the complete data history can be found. One other intermediate-term positive is that the SPX/Nasdaq Relative Strength indicator that I track on the charts page has now flipped and the Nasdaq is again in a leading position. Since the inception of the Nasdaq in 1971, the SPX has made all its gains when the Nasdaq was in a leading position. More details on this indicator can be found in the 5/26/09 blog. Subscribers can also download the models (both Excel and Tradestation) from the downloads page.

So POMO, momentum, and relative strength continue to favor the bull case. The negative intermediate-term studies are based on seasonality, breadth, and bond action. This means there is still quite a mix of studies and indicators for the intermediate-term. With the trend still favoring the bulls I'm inclined to give them the slight edge. I will continue to look for trades in both directions but will trade the short side with a bit more caution.
